Grammar school, grade 12 with promotion to grade 13, in connection with a one-year work placement\* (together Fachhochschulreife)

Applicants who have completed vocational training may embark on a degree programme related to the field of training. Requirements: applicants must have completed a recognised apprenticeship lasting at least two years, followed by a minimum of three years working in that field. Applicants with no experience in the intended field must take an admissions test.

### 1. Definition of the work placement

Work placements should generally be suitable for providing insight into creative employment and the practical working conditions involved. Schools and school-like institutions are unsuitable for giving a realistic picture of operational practice.

Work placements at advertising and design offices and agencies, with graphic, industrial and product designers, in print design, with video production companies or television broadcasting companies, photographic studios and exhibition stand construction companies, on the other hand, are ideal.

Practical activities in manual or machine work or design techniques in metal-, wood-, plastics- and textile-processing companies, e.g. metal: goldsmiths and silversmiths, metal structure companies, locksmiths; wood: cabinetmaker's workshops, carpenter's workshops, shopfitting companies, interior designers; plastics: plastics processing; textile processing: upholstery, tailoring, weaving mills are also acceptable. Equally acceptable are activities in draughting offices (technical drawers, architects), model-making and mould design and shopfitting companies, stone masons, sculpture, painting, window dressing, or practical experience in manual or machine work and design techniques, particularly in graphics/ photographic companies, e.g. printers (letterpress, offset printing, silk-screen printing), lithographer, photosetting and reproduction companies (prepress, signs, stamps, engraving, illuminated advertising, labels), specialist photo labs and bookbinders.

#### 2. Proof

The work placement must be completed prior to embarking on your studies and must be proven upon enrolment at the Admissions Office (certificate issued by the employer stating which activities were performed and the exact starting and completion dates).

### 3. Transfer of training periods to work placement

Periods spent carrying out a relevant apprenticeship, relevant work in the context of vocational training in grade 11 of technical college or relevant work within the framework of a one-year work placement facilitating access to studies (= one-year guided work placement, see No. 4) can be transferred wholly or partially.

Periods of military, civilian or development service can be accredited to the work placement up to a total of six months if the work performed was comparable with the activities required for the relevant training areas in accordance with training regulations for grade 11 of technical college.

## 4. Definition of one-year guided work placement

The one-year guided work placement (one-year work placement) carried out in order to gain *Fachhochschulreife* must correspond to practical training in grade 11 of technical college and should be related to the degree programme. It should contain the same activities as required in the work placement (see No. 1).

The district governments – Departments 42 – of Arnsberg, Detmold, Düsseldorf, Cologne and Münster are responsible in the Federal State of North Rhine-Westphalia for providing information about guided work placements and for deciding about the transferability of periods of military, civilian or development service.

If Fachhochschulreife was gained following school education (e.g. two years at commercial college, completion of grade 12 of the new grammar school sixth form at secondary level II) and a one-year guided work placement, the following cases must be differentiated:

### The one-year guided work placement was related to the chosen degree programme and included the activities required for work placements (see No. 1).

It is not necessary to complete a three-month pre-study work placement.

### b) The one-year guided work placement was not related to the chosen degree programme.

In this case, the three-month work placement, as described in No. 1, must be completed and documented.

### 5. Admissions requirements in exceptional cases in accordance with § 66 (2) HG

Applicants with no experience in the intended field who are exceptionally talented in conception/design, exceeding aptitude related to the study programme, and who can prove their general education corresponds to the requirements of the university of applied sciences, may not have to prove they have *Fachhochschulreife*. Exceptional conceptual/design aptitude must first be proven in an examination taken at the Faculty of Design. Then the examination to determine the applicant's general education must be taken.

### **IMPORTANT:**

To avoid any difficulties during enrolment, it is strongly recommended to obtain confirmation from the Dean of the Faculty of Design concerning recognition of the work placement required as a special condition for enrolment in good time if it is not absolutely certain that it complies with the content described above (see No. 1).
